Hands-on Sustainability Education Program This year, more than 500 students from pre-school through college visited TLC Farm for experiential education focused on a variety of sustainability-focused topics. The experiences that students have coming to the farm can be a life changer (literally - in a recent letter we received from a PSU freshman after his class visited, he wrote "Visiting TLC farm has truly inspired me to make some drastic changes in the way I live my life." This is not uncommon!) Schools & Programs that have brought their students to TLC Farm in 2013 included: Cedarwood Waldorf School, Oregon Episcopal School, Tualatin Hills Parks & Recreation Department, Portland Parks & Recreation Department (90 kids in one day!), Portland Head Start Preschool, Boys & Girls Aid Society, Lewis & Clark College, Portland State University (three different classes), Evergreen State College. *Rooted Seeds* TLC Farm also sponsored the Rooted Seeds Journey, which sent two ambassadors to Europe to learn ancestral traditions, lifeways, and ceremonies from elders with connections to that land. Such learning is being returned to those with European ancestry who have settled in this region, through workshops, events, and partnerships.

4b (Code:) (Expenses \$ 4,689 including grants of \$ 0) (Revenue \$ 10,349)

Community Capacity Building program. We love sharing this special land with other groups - giving them a place outside of the usual city grind to refresh themselves, their relationships and their strategies *Forum*: We have made this unique place available to a broad diversity of people to use for their meetings, parties, trainings, personal and organizational retreats and events. A sample of groups that used TLC Farm this year include: Right 2 Dream Too; Kasama; Portland Rising Tide; City Repair's Village Building Convergence; Alberta Co-op and more. We also host Mother Earth School, including the country's first bio-immersion kindergarten, the Faery Garden pre-school, and a summer camp: 22 wonderful children who come daily for their pre-school & kindergarten classes, as well as 45 in the summer camp. *Events*: TLC Farm hosted a large interactive celebration in 2013: our Holiday Open House, which was an open house for our new community gathering space. This large and lively gathering wove together music, art, education, food and family fun for scores of participants.

4c (Code:) (Expenses \$ 15,867 including grants of \$ 0) (Revenue \$ 24,000)

Demonstration Program. *Sustainable Structures*: Added to TLC Farm's public spaces by installing a gently used 30-foot yurt, and making a beautiful floor for it out of recycled doors - an example of creative reuse. *Organic Garden & Food Forest*: Maintained the large educational gardens and two Food Forests (multi-level perennial food production systems that mimic the production of a natural ecosystem). Tended the 40 young trees we grafted in 2011, in preparation for planting in the Food Forests in January 2014. *Animal Husbandry*: TLC Farm is one of the only educational urban farms in the Portland area to provide access to a dairy goat herd, a rare opportunity to visit with and learn about traditional farm animals; the goats also remove invasive species by browsing blackberries. A rotating chicken flock also provides eggs & education. *Native Plant Restoration*: Continued our systematic program, in coordination with the Tryon Creek Watershed Council, of eradicating blackberries from the conservation easement and replanting with native plants. *ReCode Oregon*: Recode continued to work hard throughout the state and with the Oregon DEQ to revise onsite sanitation regulations to allow for more accessible onsite sanitation, including writing the code for composting toilets and working with the DEQ to draft performance-based codes.
